Once again, you are able to select from more 20,000 local charities from CFC campaigns across the country.

Local charities marked with a green heart icon  belong to this campaign. Those marked with an orange UG symbol  mean they belong to CFC's outside this campaign area. Federations outside the local campaign area will have their four digit CFC campaign code in square brackets [0000].

New advanced search options allow you to view all the UG charities or hide the UG charities in searches and lists. In addition, the ability to sort the list by distance from a zip code has been added (for those charities that submit address information).

UNIVERSAL GIVING (UG) permits donors to pledge to any approved CFC charity no matter where the donor or the charity is geographically located.

UG charities are too numerous to be listed in the paper brochure and can only be accessed online.
